KNOW ALL MEN BY THESE PRESENTS:

That William F. Ogden, Jr., the undersigned as the Incorporator, a resident of 1505 Xanthus Lane, Plymouth, Hennepin County, Minnesota 55447, and of legal age, has this day voluntarily formed a nonprofit corporation under the laws of the State of Montana, and for that purpose does hereby certify:

I

The name of the corporation is Eagle Rock Reserve Owners' Association, Inc., hereinafter called the "Association."

ΙI

The registered office of the Association is located at: Morse House, Gateway Axtel Road, (P.O. Box 293), Gallatin Gateway, Gallatin County, Montana 59730.

III

Richard C. Morse, a Montana resident, whose address is Morse House, Gateway Axtel Road, (P.O. Box 293), Gallatin Gateway, Gallatin County, Montana 59730 is hereby appointed the initial registered agent of the Association.

ΙV

PURPOSE AND POWER OF THE ASSOCIATION

This Association does not contemplate pecuniary gain or profit to the Members thereof, and is formed to provide for maintenance, management and preservation of and to administer and enforce the covenants and restrictions declared in the Declaration filed by Eagle Rock Ranch Limited Partnership, Elinor K. and William F. Ogden, Jr., the "Declarant", on certain residences, improvements, qualities and land that comprise and are contained within that certain tract of property of approximately 774 acres which is described as Eagle Rock Reserve, and is located in Gallatin County at the south end of Tayabeshockup Road, together with such other property as may be added thereto, all hereinafter called "Properties", and to promote the interests of the owners of such Properties.

This Association shall have and exercise any and all powers, rights and privileges of a corporation organized under the Montana Nonprofit Corporation Act as amended and shall perform all of the duties and obligations of the Association as set forth in the Declaration and the Bylaws of the Association, and Amendments thereto.

MEMBERS AND VOTING

Every record owner, whether one or more persons or entities, of a fee simple title to any division of said Propeties which is a surveyed portion of the Properties and is defined as a Parcel in a master plan adopted by the Declarants and referred to in the declaration of covenents and restrictions filed by the Declarant, but excluding those having such interest merely as security for the performance of an obligation, shall be a Member of the Association. Membership shall be appurtenant to and may not be separated from ownership of any Parcel or portion which is subject to assessment.

The Association shall initially have two (2) classes of voting membership:

Class A Members shall be all record owners with the exception of the Class B Members named below. Class A Members shall be entitled to one (1) vote for each Parcel owned. more than one person holds an interest in any Parcel, all such persons shall be Members. The vote for such Parcel shall be exercised as they among themselves determine, but in no event shall more than one (1) vote be cast with respect to any In the event, however, that there is a dispute among two or more Members regarding the vote of a Parcel in which such Members hold an interest, the Association, being duly notified in writing by any such interested Member that the dispute exists, may appoint an officer of the Association or an independent party to cast such vote on behalf of the Owners of the Parcel in a manner as such officer or party, in his sole discretion and business judgement, may decide as being in the best interest of the Association; all Members shall be deemed to have provided the Association and such officer or party their proxy on such occasion.

Class B. Class B Members shall be the Declarant. Class B Members shall be entitled to one and one half (1.5) votes for each Parcel owned. The Class B membership shall cease and be converted to Class A membership on the happening of either of the following events, whichever occurs earlier:

- (a) When the total votes outstanding in Class A membership equal the total votes outstanding in the Class B membership, or
 - (b) on December 31, 2005.

VI

BOARD OF DIRECTORS

The affairs of this Association shall be managed by a Board of of not less than three (3) nor more than fifteen (15) directors. The names and addresses of the persons constituting the first Board of Directors, to hold office until the first annual election of directors are: (3) initial directors

DISSOLUTION

The Association may be dissolved under resolution of dissolution and plan of distribution with the assent given in writing and signed by Members having not less than seventy-five (75) percent of the total votes of the Members. Upon dissolution of the Association, other than incident to a merger or consolidation, such plan of distribution shall provide that the assets of the Association shall be applied to the discharge of all liabilities and obligations of the Association and then such assets remaining shall be distributed to the members pro-rata by Parcel ownership or shall be dedicated to an appropriate agency or entity to be used for purposes similar to those for which this Association was created. In the event that such dedication is refused acceptance, such assets shall be granted, conveyed and assigned to any nonprofit corporation, association, trust or other organization to be devoted to such similar purposes.

VIII

TERM

The corporation shall exist perpetually.

IX

AMENDMENT

Amendment of these Articles shall require the assent of Members having seventy-five (75) percent of the votes of the entire membership.
